

### LIMITED WARRANTY CERTIFICATE

This limited warranty (this "**Warranty**") provided by ParaZero (the "**Company**") with respect to the SafeAir Phantom/Mavic (the "**Product**") and shall be governed solely and exclusively by the terms and conditions set forth below:

1. The Company warrants that the Product will be free of defects in material and workmanship under standard use, for a period of twelve (12) months from the date of purchase by the customer (the "**Warranty Period**"), all subject to and in accordance with the terms and conditions hereof.
2. The effectiveness of this Warranty with respect to each Product shall be subject to and contingent upon the full payment of the consideration due for such Product by the customer to the Company.
3. The Company's sole obligation and customer's sole and exclusive remedy under this Warranty shall be limited, to the repair and/or replacement (in the Company's discretion) of any defective Product (and/or any component thereof) which was proven not to conform to its respective specifications and which shall be returned by the customer to the Company's facility during the applicable Warranty Period in accordance with the procedure set forth below.
4. Customer must follow Company's then-current procedures in connection with any return of a Product.
5. This Warranty shall not apply to a Product which has been maintained, repaired or altered not in accordance with the Product's manufacturer's instructions, nor shall it apply to a Product which has been subject to misuse, unauthorized use, negligence, accident, (including fire, water, explosion, smoke, vandalism, etc.), or which has been operated contrary to the Product's manufacturer's instructions, which prohibits, among others attempts to make any internal changes, removals, attachments or additions to the product or components thereof, by anyone other than Company's authorized personnel or subjected to or stored under any unusual or excessive environmental conditions. It shall be further clarified that this Warranty shall not apply to any damages and/or failures and/or defects to a Product (or due to any use of the Product) caused as a result of the Product installment and/or the lack of maintenance of the Product in accordance with the Product's manufacturer's instructions.
6. SUBJECT ONLY TO ANY MANDATORY REQUIREMENTS OF THE LAW WHICH CANNOT LEGALLY BE CONDITIONED UPON, THIS WARRANTY SHALL BE EXCLUSIVE, IN LIEU OF ANY AND ALL OTHER WARRANTIES, GUARANTEES, PROMISES, OR REPRESENTATIONS WHETHER WRITTEN, ORAL OR IMPLIED, AND NO OTHER WARRANTY IN RESPECT TO THE PRODUCT, IS OR WAS GIVEN BY THE COMPANY, SUCH THAT ANY OTHER WARRANTY, INCLUDING WITHOUT LIMITATION WITH RESPECT TO MERCHANTABILITY, SATISFACTORY QUALITY OR FITNESS FOR A PARTICULAR PURPOSE IS HEREBY EXPLICITLY DISCLAIMED.

SUBJECT ONLY TO ANY MANDATORY REQUIREMENTS OF THE LAW WHICH CANNOT LEGALLY BE CONDITIONED UPON, IN NO EVENT WILL THE COMPANY, ITS AFFILIATES, SHAREHOLDERS, DIRECTORS, OFFICERS, EMPLOYEES OR ANY PARTY ON THEIR BEHALF, BE LIABLE FOR ANY INCIDENTAL, INDIRECT, SPECIAL, CONSEQUENTIAL, EXEMPLARY OR RELIANCE DAMAGES, LOSSES, EXPENSES (INCLUDING, WITHOUT LIMITATION, LOSS OF PROFIT, OR COSTS OF PROCUREMENT OF SUBSTITUTE GOODS OR SERVICES, OR LOSS OF DATA OR USE), OR ANY CLAIMS OR DAMAGES BROUGHT BY ANY THIRD PARTY, RELATING TO OR ARISING IN CONNECTION WITH THE PRODUCT, HOWEVER CAUSED, AND WHETHER BASED ON CONTRACT, TORT, EQUITY OR ANY OTHER THEORY OF LIABILITY WHATSOEVER, EVEN IF COMPANY WAS NOTIFIED OR OTHERWISE AWARE OF THE POSSIBILITY OF SUCH DAMAGES, LOSSES OR EXPENSES. COMPANY'S AND/OR ANY OF ITS AFFILIATES' MAXIMUM LIABILITY FOR DAMAGES UNDER THIS WARRANTY SHALL BE LIMITED TO THE AGGREGATE SUM PAID BY THE CUSTOMER TO THE COMPANY AS CONSIDERATION FOR THE PRODUCT. THE LIMITATIONS CONTAINED IN THIS SECTION 6 SHALL APPLY NOTWITHSTANDING

Without limiting the foregoing, the Company does not represent or warrant that the operation or use of the Product will be timely, uninterrupted or error free.
8. The Company makes no warranties with respect to any third party "off the shelf" software from any third-party supplier that may be included with or incorporated in the Product. The Company shall assign all available warranties from such third-party suppliers, to the extent that same may be assigned, and such assignment will be the sole responsibility of the Company with respect to any such software.
9. This Warranty is solely for the benefit of the customer of the Product and will not extend or construed to be extended to any other person and/or entity whatsoever, including any of the customer's clients. Any additional warranty extended for the Product by the customer or any other third party shall not be binding upon the Company, and shall solely be borne by the applicable third party.
10. THE REPLACEMENT AND/OR THE REPAIR OF THE PRODUCT (AND/OR ANY COMPONENTS THEREOF) IN THE MANNER PROVIDED ABOVE SHALL NOT UNDER ANY CIRCUMSTANCES EXTEND A PRODUCT'S WARRANTY PERIOD. The Warranty for a replaced or repaired product shall be for a period which is the remainder of the applicable Warranty period of the original product that has been replaced or repaired.
